I. Course Description and Overall Learning Objectives

The unfolding phenomena of globalization are ushering in significant changes in the communications industry, both in the production and the delivery of information, news and entertainment content worldwide. The convergences and collisions of the telecom, media, and entertainment industries at the turn of the 21st century provide new challenges for the entities operating in the different sectors and offer potential opportunities for entrepreneurial endeavors.

This course addresses the practical and theoretical aspects of the international economy that are most relevant to management strategy in the communications industry. It analyzes the global strategies of companies competing in the international arena across a variety of industry sectors: telecommunications, the Internet, broadcasting, film, television, sports, news, and music industry. Different strategies and business practices are illustrated, similarities and common trends are identified in a global landscape shaped by the increasing digitalization of media content and platforms.

The broader goal of the course is to increase the economic literacy of the participants addressing the international dimensions of the communications industry, and specifically deepening their ability to understand the dynamics of the production and distribution of communication content as well as the different delivery platforms at a global level.

- **4. Course project.** Student will individually conduct research on a topic related to this course. A one page synopsis of the project should be submitted for approval by March 10. The final presentations will take place in the last two weeks of classes, and they must include visual aids and a short paper (8-10 pages suggested) to be submitted via e-mail to the instructors by 1:50 pm, April 25.
- **5 Final exam.** There will be a take-home final exam due to the instructor via e-mail by 4:00 PM PST, Monday May 9.
