Master of Historic Preservation/Heritage Conservation Thesis ARCH 691b (4 units) Spring 2018 Instructor: Trudi Sandmeier Graded – IP/CR/NC

This course is divided into two parts – the A portion is devoted to the preparation of the student to embark on their thesis research. The B portion is structured to allow the student to pursue their research agenda and to write their thesis.

ARCH 691b

This class is open to students who have satisfactorily completed ARCH 691a and have the permission of the Director of the Program. This class is designed as an independent study course.

It is expected that students will spend a MINIMUM of 12 hours a week working on their thesis.

Each student will meet **WEEKLY** with their thesis committee chair, and on an as needed basis with their committee members, over the course of the semester to review their research and progress toward completion. A thesis will be due at the conclusion of the research. This thesis must conform to university requirements as listed the university catalogue (http://catalogue.usc.edu/content.php?catoid=7&navoid=1767).

The Chicago Manual of Style (CMS) (16th or 17th edition / notes-bibliography style) is the citation format required for an MHC thesis. There is a link to the online version of the CMS on Blackboard.

4.	THESIS OUTLINE – please submit your 250 word abstract and the working outline of the contents of your thesis. Please describe chapter contents in as much detail as possible. Please email to both instructor and committee chair (if different).
