Summary: The course presents modern neural learning and computational intelligence techniques with a special focus on *probabilistic* descriptions. This includes neural systems, deep learning, adaptive pattern classification, fuzzy function approximation, and other hybrid machine-learning systems. Applications to signal processing (including financial engineering). The instructor will provide supplemental notes and software. Students will work in pairs to prepare and present a final project that applies computational intelligence techniques to an approved problem.

Aug 22: Computational intelligence. Feedforward and feedback neural nets.
Aug 29: Feedback stability. Uncertainty types. Multilayer perceptrons.
Sep 5: Regression and classification. Probable inference. Rational asset pricing.
Sep 12: Two-stage RAP. Multivalued sets. Probability framework: Mixtures.
Sep 19: IP. Backpropagation probability. Expectation-Maximization (EM).
Sep 26: MIDTERM I. Deep learning. Backpropagation as EM. Noise boosting.
Oct 3: CAP. Standard additive model. Watkins representations. Mixture rules.
Oct 10: Expert fusion. SAM supervised learning. Generalized mixture learning.
Oct 17: Approximator statistics. Bayesian inference. *Project proposals due*.

GRADING PROCEDURE

1. **Midterms.** Two midterms. Each worth 25 points.
2. **Homework.** Checked and recorded. Not graded. A perfect set of worked homework problems can earn 10 points. Lesser homework sets earn fewer points. Grade stays as is if only some homework turned in. How much homework counts for how many points lies at the discretion of the instructor and teaching assistant. Students may discuss the homework problems among themselves but each student must work his or her own problems. Cheating warrants a course grade of F.
3. **Project.** Well prepared and presented project worth 50 points. Exceptional projects can earn an automatic course grade of A. Hence: *Project excellence trumps all else.* Projects must have the instructor's written approval. Failure to present a project on schedule results in automatic course grade of F. Project evaluation at discretion of instructor and teaching assistant. View project as the final exam.
