Course Description

Strength of Materials is a first course in the field of solid mechanics. Studying the properties and behaviors of materials is crucial in prediction of structural failure in any industry application. This course provides principles

of mechanics and their application to analyze basic engineering problems.

Learning Objectives and Outcomes

Understanding and applying the concepts of stress and strain deflection of mechanical elements due to tension, shear, bending, or torsion; combined loads; energy methods, statically indeterminate structures; strength-based

design.
