Syllabus CTPR 534 Intermediate Production Design

2 Units Fall 2020 Prerequisite: CTPR 508 Instructor: Nathan Ogilvie SA: Cheyenne Peerson

Course Objective: Learn and experience the process of Production Design as it applies to an overall knowledge of the cinematic arts.

Grades are based on: 55% Assignments & in-class projects

30% Final Project & presentation

15% Class participation

Students are expected to be on time and prepared for each class. Two absences will result in a student's grade being lowered by one full letter (IE: A becomes B). A third absence will result in a student's grade being lowered by one, additional full letter (IE: B becomes C). A student's grade will be lowered by one full letter for each additional absence. Week 1 8/20 Course Overview & Dissecting a Script

Discuss the responsibilities of a production designer, communication, & design principles. Turning a script into designable elements.

ASSIGNMENT: Using selected script, students create set list, identify main characters, theme, visual keys.

Week 2 8/27 Developing a Visual Concept

Review Week 1 assignment. Discuss in class; critique from instructor.

Discuss creating a visual concept for the script and establishing composition, chroma, and chiaroscuro themes for a script.

ASSIGNMENT: Using selected script, students create create mood board and title graphic.

Week 3 9/3 Visual Research and Presentation

Review Week 2 assignment. Discuss in class; Peer review in class.

Discuss effective image research and creation of strong presentations.

ASSIGNMENT: Using selected script, students create varied research portfolio.

Week 4 9/10 Location or Stage

Review Week 3 assignment. Discuss in class; critique from instructor.

Discuss considerations and preparations for creating a set on location or on stage.

ASSIGNMENT: Using selected set from script, students create a location presentation.

Week 5 9/17 Blocking the Scene to Develop a Ground Plan

Review Week 4 assignment. critique from instructor.

Discuss blocking and designing based on a script analysis.

ASSIGNMENT: Using selected set from script, students plan character action.

Week 6 9/24 SketchUp Class I

The lecture is devoted to SketchUp instruction.

ASSIGNMENT: Setup SketchUp workspace

Week 7 10/1 SketchUp Class II

The lecture is devoted to SketchUp instruction.

ASSIGNMENT: Print document to scale

Week 8 10/8 Visual Composition - Drawing to create

Review Week 7 assignment. Discuss in class; critique from instructor.

Discuss creating drawings and renderings to communicate the set. Discuss architectural styles. How architecture informs story.

ASSIGNMENT: Using a set from selected script, students develop a ground plan, elevation, and perspective drawing.

Week 9 10/15 Materials and Textures

Review Week 8 assignment. Discuss in class; critique from instructor.

Discuss wall and floor treatments. Examine how surfaces interact with architecture to create an environment. Discuss graphics and illustration with in a set.

ASSIGNMENT: Based off a set from selected script, students create material boards.

Week 10 10/22 Set Decoration

Review Week 9 assignment. Discuss in class; critique from instructor.

GUEST: Set Decorator

Lecture & discussion about furniture, lighting fixtures and drapery.

ASSIGNMENT: Using a set from assigned script, students research and present set decoration choices.

WEEK 11 10/22 The Departments

Review Week 10 assignment. Discuss in class; critique from instructor.

General lecture & discussion of the Art Department Team: art director, set designer, illustrator, storyboard artist, art dept coordinator & graphic designer, construction, set decorator, prop department, locations manager & staff.

Discussion of scheduling, and budgeting visual work.

ASSIGNMENT: Students select final project script and complete assignment revisions.

Week 12 11/5 Visit a Set

Virtual tour working soundstage and discussion with the production designer.

ASSIGNMENT: Students create set list and set breakdown for selected set from final project script.

Week 13 11/12 VFX, SFX, and backdrops FINAL PROJECT ASSIGNMENT

Review semester assignments. Discuss in class; critique from instructor. Discuss the challenges and approaches to take when working with Special Effects and Visual Effects.

GUEST: VFX producer

ASSIGNMENT FOR THE FINAL PROJECT: select a script from the choices provided or present an alternative for approval. Final project requirements include designing one set, and one location including mood boards and SketchUp drawings, materials board, and verbal in-class presentation of the design. Each student discusses their chosen script, presents visuals, discusses the concepts and outlines their approach to the script. Presentation must include brief analysis of script, color palette, tone, character, period and locations.

FINAL EXAM WEEK:

Final Project presentations.
