

## **BISC 542: Seminar in Computational Biology**

**Objective:** To provide experience and training in giving science research presentations.

**Format:** All students will give two 20 – 30 minute presentations. At least one of these presentations will be on the student's own research. The second presentation can also be on the student's own research, or can be on a journal article. Students should discuss the topic of their presentation with me beforehand. Students will make their own slides. Each student's two presentations will be on different days, and will use different slides. The audience for these presentations is a general scientific audience.

Students that are not presenting that week are expected to attend, participate in a class discussion, and fill out evaluation forms. These forms are to give feedback to the presenters.

In addition, students are expected to attend the Departmental Computational Biology Seminars. These seminars are usually on Thursdays from 2:00 – 3:00 PM.

**Schedule:** On the first lecture we will fix the student presentation schedule. On the second lecture we will have a class discuss on good and bad presentations. Subsequent weeks will have presentations by two different students. Note: there will be no class on Thursday, April 22 (Spring Wellness Day).

**Grading:** Credit/no credit. Credit requires regular attendance, giving presentations, and returning evaluation forms.
