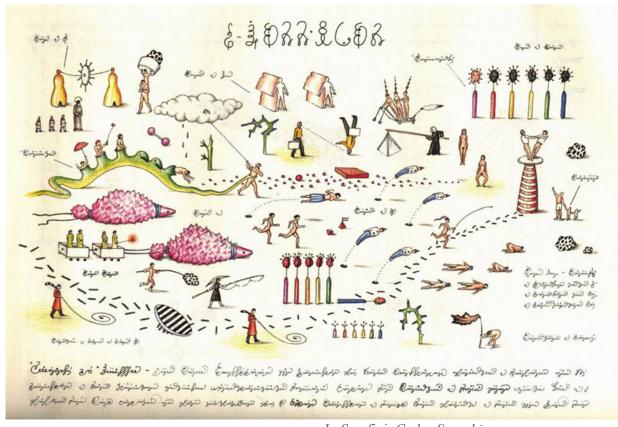

# Course Description

World Design is a design practice integrating visual and scenario design in the construction of worlds as containers for narrative. World Design as an approach to narrative recognizes and documents interlocking systems of value and potential, creating conditions for choice, action and character across media to craft transmedia worlds. World Design encourages story development from diverse worlds and perspectives. The course welcomes projects across genres: documentary, drama, speculative fiction, fantasy and experimental immersive experiences.

3D modeling and visualization skills have emerged as essential tools for filmmakers from concept through production. In this course students will familiarize themselves with the basics of SketchUP, a 3D modeling tool. Using this tool, students will create wireframe models to visualize scene and story development. 3D modeling and animation tools can also be applied to VR, AR and 3D-Stereo projects. World Design practice integrates with the SCA Production curriculum; class projects may be developed in parallel with projects in other Production Department classes or applied to future work.

#### Course Goals

- Familiarize students with the concepts, work-flow, and tools of World Design including Placemaking, Embedded Narrative and Visualization.
- Acquire basic 3D Visualization tools using SketchUP\* \*No previous experience with 3D modeling necessary. Students may opt to use other pkgs.
- Clearly articulate visual and narrative elements of place, character and scenario.
- Create and document a comprehensive World Design in parallel with a current production project or as development of a future project. This document can be delivered with or without a completed script.

#### Course Structure

The course is run as a workshop for students to develop a project over the course of the semester and produce a World Design Document that defines and documents the broad outlines of a world, including one scene treatment illustrated with a 3D visualization. The elements for the World Design Document will be assigned in class to be uploaded into the class gDrive before 9AM of the stated due dates. Classes consist of lectures, in-class exercises and critique. There may be occasional posted readings and outside speakers. Final Presentations are Week 14, Final Revisions Due Week 15. There is no final exam. \*The schedule is subject to modification due to availability of speakers.

# Requirements and Grades

Students are expected to come to class prepared and to participate actively in class discussions. Assignments must be submitted on time. Due to the limitations of ZOOM, some screenings will be assigned viewing before class. Assignments are due, either posted on class drive or via email to class email by 9AM (class time) of due date.

Please contact the Instructor and SA with any conflicts or issues pertaining to the virtual classroom. Consult SCA Creative Tech for technical issues. Directions regarding Zoom-related prompts for presentations and participation will be given in class.

Class begins promptly; excessive tardiness will be counted as an absence. Attendance assumes that your webcam is enabled throughout class. The only acceptable excuses for missing a class or taking an incomplete in the course are personal illness or a family emergency (with authorized documentation). Students must inform the professor before an excused absence or it will be counted as unexcused. One unexcused absence requires a meeting with the instructor and may affect your grade; two unexcused absences will lower a student's final grade by one third (i.e. from an A to an A-).

This class is run as a workshop and, as such, requires thoughtful and attentive attention to all class projects. The Class Participation grade reflects quality as well as quantity, i.e., the ability to engage in constructive and meaningful critique of fellow classmates' work as outlined in USC CET Menu of Discussion Norms.

Note: Not story, not characters: Premise. "A world where...."

Why this world? What are you exploring? What does this mean to you? POV?

11. World Guide

Contents will vary according to the specifics of your world; sci-fi has different needs than althistory or naturalistic world. Document available resources. Anticipate categories that the creative team, and viewers, will need to understand your world and your characters. Example:

#### History

Outline history/culture critical to understanding your world/premise, i.e. present day requires less explanation than history, alt-history, sci-fi.

Socio-economic structure / Resources

Who has power, access to resources? How is the balance of power maintained?

Relevant formal laws and repercussions, relevant social norms, application of laws, penalties, knowledge of laws, including informal laws.

Technology (if applicable)

Beliefs (if applicable)

Magic / Time Travel / Physics of Space / Survival etc.

Other cultural or social aspects to record critical to understanding behavior and events: possibly sports, institutions, transportation, language...

11. Scene Treatment

A treatment, a brief description, of an encounter among beings that inhabit this world. The scene may not even end up in your final project, but the encounter, the fated/chance/unlucky or lucky meeting is an inevitable product of the place you've defined within your world.

12. MODEL+ 3 Views: Walk through from Folder 3 /3

You may opt for a physical model + sketches.
