Course Description

In-depth exploration of the mindsets, personalities and social, cultural and political factors that led to the world's greatest breakthroughs.

Learning Objectives and Outcomes

The goal of this course is to introduce the concept of the Creator's Mindset, a world view that defines and contributes to innovative thinking, gives birth to new ideas and provides a context of revolutionary and creating thinking. The course examines exemplars which typify this mode of thought and gives students hands on experience putting these ideas into practice both by analyzing the creator's mindset as well as producing a final project.

Description and Assessment of Assignments

Students will complete two major projects for the class.

Creator's Mindset Analysis

Following the structure of the class, each student will complete a 7-10 page essay that identifies someone they feel exemplifies the creator's mindset as defined in class. The paper will be evaluated based on how three criteria: The appropriateness of the person/topic selected, their ability to assess that person in terms of the class criteria for exemplifying the creator's mindset, and the quality of writing, analysis and research presented in their written work.

Student Project

Each student will present a final project that is their own effort to embody the concept of the creator's mindset. There will be three stages for the development of the project:

1. Submission of the project topic. All students will submit a "project pitch" which will be no more than 500 words and which will provide a project goal, a timeline, and a description of the final deliverable.
2. Review of literature. Students will complete a review of the relevant literature, which may include an analysis of similar projects, competitors, case studies, or academic research relevant to their topic.
3. Final Project and Presentation. For the final exam, students will present and demonstrate their final project in a formal class presentation.

Grading Breakdown

Academy Attendance Policy

The Academy maintains rigorous academic standards for its students and on-time attendance at all class meetings is expected. Each student will be allowed two excused absences over the course of the semester for which no explanation is required. Students remain responsible for any missed work from excused or unexcused absences. Immediately following an absence, students should contact the instructor to obtain missed assignments or lecture notes and to confirm new deadlines or due dates. Extensions or other accommodations are at the discretion of the instructor.

Automatically excused absences normally may not be used for quiz, exam or presentation days. Using an excused absence for a quiz, exam or presentation, such as in the case of sudden illness or other emergency, is at the discretion of the instructor.

In the case of prolonged illness, family emergencies, or other unforeseen serious issues, the student should contact the instructor to arrange for accommodation. Accommodation may also be made for essential professional or career-related events or opportunities. All accommodations remain at the discretion of the instructor, and appropriate documentation may be required.

Fall 2021 addendum:

- Unless students provide an accommodation letter from USC's Office of Student Accessibility Services or a letter from IYA Student Services detailing visa or travel restrictions, attendance and active participation is expected in the classroom. Any student with such accommodations should submit their accommodation document to the instructor as soon as possible to discuss appropriate accommodations.
