## Course Description

Strength of Materials is the first course in the field of solid mechanics. Studying the properties and behaviors of materials is crucial in predicting structural failure in any industry application. This course provides principles of mechanics and their application to analyze fundamental engineering problems.

## Learning Objectives and Outcomes

- Apply the concept of stress and strain deflection to various mechanical structures
- Analyze and interpret tension, shear, bending, torsion, buckling, and combined loads
- Employ a strength-based design approach
- Analyze statically indeterminate structures
- Utilize energy methods to analyze structural members
- Develop a comprehensive and methodical strategy to solve real-world engineering problems
