COURSE DESCRIPTION

Introduction to the study of 3-D Design. Includes a wide investigation of materials, tools, and techniques specific to dimensional design as they apply to package, product, and environmental design. The ability to understand and experiment with materials, media and the tools applied to 3D lies at the core of this studio-based class. Building on design concepts introduced in DES102 - Design Fundamentals, students will be introduced to the key principles of materials integral role in design.

Coursework explores a range of materials through in-class exercises, projects, and instruction. Students will investigate means of production and construction using both the hands-on traditional and digital tools available to them. Experimentation is a critical part of design and innovative thinking, so the challenge to explore will be a focus during the term. The study of the design process in visual problem solving will frame that investigation.

Students are expected to actively participate in the design process through sketching; rapid visualization (prototyping); and creating dummies and comprehensives.

OBJECTIVES

Students will have the ability to understand basic three-dimensional concepts as they apply to design.

Students will examine materials, media, and tools as they apply to 3D.

Students will have an introduction to 3D technology to visualize built forms and prototyping.

Students will have an understanding of the principles of material selection and their appropriate application.

The course will draw upon the design process and it's application to visual problem solving.

Students will be expected to evaluate their work and others in a critical manner.
