Course Description

This course will introduce students to the regulation of land, restrictions on its use, and strategies to navigate within this framework in order to entitle and develop land. The course is designed to familiarize students with standard zoning and land use policies, issues and procedures encountered by developers. The course will focus on local governance, securing entitlements, environmental regulation, community/stakeholder involvement and government relations and how these fit into the development process. Because most land regulation and policy is local, and changing all the time, the course will focus on training students in general concepts and skills rather than specific laws or ordinances. Nonetheless, the course's geographic focus will be primarily the United States and California.

Learning Objectives

- 1. To provide a working knowledge of key land use regulatory and zoning concepts relevant for future real estate developers.
- 2. To familiarize students with the players and processes that shape land use policies, regulations and decisions.
- 3. For students to learn to "issue spot" potential development issues during the project due diligence and entitlement phase and use tools to possibly affect the outcomes.
- 4. For students to problem solve in situations where projects have multiple competing interests and to consider and weigh those competing interests.
- 5. For students to think critically about current issues in the land use field as they relate to urban planning and real estate development and how these may impact a project.

Course Notes

The course will use Blackboard, PowerPoint slides and other materials that will be posted online. Students are advised to check Blackboard at least twice a week.

Required Readings and Supplementary Materials

California Land Use & Planning Law, Cecily Talbert Barclay and Matthew S. Gray, 37th Edition2020 ("Barclay/Gray").

The Instructor will provide supplemental reading materials on Blackboard.

Students are required to read all assigned material <u>prior</u> to the class session in order to prepare for the class discussion and lecture.

Description and Assessment of Assignments

Assignments are to be submitted as follows:

Planning Commission Assignment: In assigned groups, students are required to attend one meeting of a local planning commission (or if virtual, review the hearing audio/video) and prepare a brief report and presentation. The oral presentation will be given by students during the Class specified below, all team members must participate, and the report must be submitted no later than 6:00PM PST that same day. Student's may attend commission meetings (or if virtual, review the hearing audio/video) in other jurisdictions if approved in advance by the Instructor. Details on this assignment as well as sign-up details will be posted on Blackboard. By Class #5 teams must have an identified and instructor-approved project before a planning commission. No two teams may have the same project, therefore it is to team's benefit to identify a project early. It is important that all team members participate as all team members will receive the same grade. Team members will grade each other's contribution and at Instructor's discretion, this grade may account for 10% of an individual's grade for the team project. Make every attempt to email with last minute questions 48 hours prior to assignment being due.

Homework Assignments: These assignments will be posted on Blackboard during the class prior to when they are due. Students not in attendance will be required to obtain the assignment on their own to complete and submit when due. Assignments are due at 6:00 PM PST. Please upload your assignment using the "Assignment" and the "Turnitin Assignment" tabs. Make every attempt to email with last minute questions 48 hours prior to assignment being due.

Homework assignments will be graded on thoughtful attention to questions and detail, response to the actual questions asked and each component of the question asked, if a multiple-part question, and explanation of how conclusions were drawn. While points cannot be gained or lost on presentation, it is a good professional and future exercise to consider the appearance of your finished work, including use of headings, legible fonts, and professionally and neatly-printed materials.

Midterm Exam: The Midterm Exam will be held during Class #7. The Midterm will be open book and open note. Details will be provided in the class prior to the exam.

Final Exam: The Final Exam will be held in Class when assigned by the University Calendar. The Final Exam is open book and open note. Details will be provided in the class prior to the exam.
