This class will introduce students to the basic concepts of environmental and resource economics, principles and methods that are used to develop economics policy responses to environmental problems. We look at how fundamental thinking in economics is applied to environmental policy around issues such as emission reduction, improving air quality, sustainable agricultural practices, water and land conservation and environmental management.

This course is built both on lectures and on student discussions, work sheets and class activities. Students are expected to review the required resources (podcasts, news articles, videos) shared via blackboard before lectures.

Readings:

1. Textbook: Tietenberg & Lewis (T&L). *Environmental & Natural Resource Economics*, 10th edition. ISBN: 9780133479690. Other editions of the textbook are OK to use.

2. Other **required** readings will be posted on the Blackboard on the weekly basis. Some exam questions will refer to these readings.

Course goals:

1. Understand and learn to use fundamental economics concepts in environmental policy

2. Learn to identify the economic expression of a policy action

3. Develop mathematical expressions to connect ecological issues with economic and social processes.

4. Learn about specific environmental problems and the role economics is playing in addressing (or not) these issues

5. Learn the fundamentals of cost benefit analysis

6. Learn about uneven impact of economic policies on different social groups

Research paper:

The writing assignment of the course is an original research paper of **minimum 10 pages** (excluding bibliography, double-spaced, 1-inch margins). This will be on a topic of the student's choice, refined in collaboration with the instructor and reflecting the student's research interests. The instructor will provide additional guidelines on how to pick a topic, structure of the paper and the required diversity of sources. Submit the paper via the Blackboard in "Assignments." In addition to the final paper you have to submit portions of the research work during the semester. See the schedule for the details. Additional details will be provided in class. Use of AI for the research paper will be considered plagiarism.

Zoom, Policy on Missed Lecture, Assignments, or Exams

ZOOM POLICY FOR THE CLASS: This is an in-person synchronous class so you are expected to be present for each lecture section. This is an interaction heavy class, I will not be allowing students to "Zoom In." There will be no Zoom recordings available for students who miss a class. You will be expected to get the notes from your fellow students and you can of course meet with me to go over any questions you may have. While it is understandable that you may have to occasionally miss a class, you are strongly recommended to avoid missing classes as much as possible. If you cannot commit to regular attendance, please let me know and we will work with your advisor to find you a suitable alternative.

UNPLANNED ABSENCES: You may be excused from an exam only in the event of a documented illness or emergency as outlined by university policy. No other excuses for missing exams will be accepted.
