## **Catalogue Description:**

Principles of human pharmacology/toxicology related to prescription, over the counter medications; nutraceuticals; drug-drug interactions; polypharmacy; hot topics related to recently approved drugs.

#### Introduction

Pharmacology combines pharmacy (the science of drug preparation) and therapeutics (the treatment of disease with drugs and other means). This course is designed for upper-level undergraduate students from science majors who want to gain a working knowledge of how drugs are administered, what happens to them once in the body (pharmacokinetics [PK]) how drugs alter disease (pharmacodynamics [PD]); and potentially damage the body (toxicology). Content also focuses on the use of prescription and over-the counter drugs to prevent and treat diseases (pharmacotherapeutics). The course should give you a basic understanding of many different classes of drugs that are commonly prescribed. It should be important for undergraduates in Pre-Pharmacy, Pre Medicine and other health and life science majors as wellas students in biomedical engineering. Chapters from the core textbook will be supplemented with a variety of source materials including online resources and articles from scientific journals.

**Course Objectives:** Upon successful completion of this course, students should be able to:

• Explain how drugs are administered and summarize the different routes of administration

- Describe the important pharmacokinetic parameters (absorption, distribution, metabolism and elimination; ADME) that affect drug dosing in a patient.
- Summarize different drug-receptor interactions and the basic principles of pharmacodynamics(PD)
- Explain the basic principles in the use of drugs to prevent and treat diseases (pharmacotherapy).
- Describe the importance of pharmacogenomics.
- Conclude why particular drugs are prescribed (selected by the clinician) and used in patients and the monitoring of their effects (clinical pharmacology)
- Justify the importance of proper drug use in the treatment of a disease and its relationship tohealth, economy, and wellbeing of society.
- Judge and debate the societal challenges and perceptions related to the economics of drug availability.
- Deduce why some drugs are toxic to humans and why some individuals have different reactions to a drug (basic principles of toxicology).

# Evaluation and Grading:

Evaluation will be based on two midterm examinations, a final examination, course quizzes and class participation.

**Final Exam (60 points):** The final exam (60 points) will include multiple choice and T/F questions as well as a series of questions involving short answers. The final exam will be cumulative but will emphasize material covered after the 2nd midterm.

## Supplement: Zoom and Blackboard

## Zoom

Zoom is a videoconferencing application that enables audio and video conferencing between multiple users on both desktop computers and mobile devices. It can allow faculty to host class lectures, discussions, share screens and files, and chat with students using a PC, tablet, or even a cell phone equipped with a camera. Zoom is available to all faculty and students at no cost.

- Instructors may host live class sessions on Zoom at the same day and timeas their regular class.
- Instructors are required to <u>record all Zoom lectures</u> and discussions for ADA
   (Americans with Disabilities Act) compliance, but also to accommodate students who may not be able to keep to the original classschedule.

# 1. Getting Started with Zoom:

- O You might be required to use Zoom in this course, please familiarize yourself with it by thoroughly reading all of the materials and the step-by-step instructions.
- O You will access the Zoom meeting space in one of two ways:
  - Log in via blackboard after you have followed the instructions to initially download, install, and login. Then enter the meeting by going to the link <u>USC</u>
     <u>Zoom Meetings</u> in the left-hand navigation pane. You will need to click the "Join" button next to the classroomfor the time set for the meeting.
  - 2. Copy and paste the URL (or click on the web link) provided by yourinstructor at the time specified for the meeting. Launch the app (after initially downloading, installing, and logging in), and you will enter the meeting immediately.
