Prerequisite: ISE 220 Foundations of Probability Modeling

Course Description: This course leverages key applications of probability and explores statistics as it pertains to quantification and assessment of uncertainty, and the principled application of information to decision-making. You will develop the skills necessary to gather data that is representative of the phenomenon that you intend to study, to describe the uncertainty in scientific results, and to draw valid conclusions in the face of uncertainty.

Text: Montgomery, Runger, and Hubele, Engineering Statistics, 5th edition

Course Material: Chapters 1-6 of the text, plus topics discussed in lecture by the instructor

Course GRADES will be determined by the distribution of point totals for the class. “Natural groupings” will be used to assign letter grades. The highest scoring group will receive A’s, the next group is the B’s, and so on. A single point will not be the difference between any two letter grades. A “gap” must exist to create a grade boundary.

HOMEWORK assignments will be due on the following Thursdays:

January 18, 25; February 1, 8, 22; March 21, 28; April 18

Late homework will be accepted until noon on the Friday following the original due date. Homework will be graded on an “all or nothing” basis. If a paper shows an answer to each assigned exercise that uses approximately the correct method, the grade for the assignment is 15 points. If any exercise is unacceptable, the paper will be returned with no points awarded. Completions of returned assignments will be accepted for full credit until noon on the Friday after the assignment is returned to the class.

A PROJECT will be due on the following date:

Thursday, March 7

The project will involve data collection and analysis to investigate a scientific claim. For this project, you will work with an assigned partner. The project assignment will be distributed about two or three weeks in advance of the due date.

An EXAM will be given on each of the following dates:

Thursday, February 15 and Thursday, April 11

Each exam will cover the material presented up to and including the preceding homework assignment. Points will be assigned to each section of the exam. Partial credit will be awarded according to work shown. No re-takes will be allowed. No make-up exam will be given. If you miss an exam, you must take the final exam.

The FINAL EXAM is scheduled for **Wednesday, May 8, at 2:00-4:00**. It will be comprehensive and will be graded similarly to the other exams. A student may elect to omit the final exam, if both exams and the project have been completed.
