### Course Description:

This course is designed to develop conducting skills at the intermediate level covering basic technique and phrasal, harmonic, and structural analysis of the score. Members of the class may function as an ensemble and each person will conduct on a number of occasions throughout the semester.

### Course Content:

1. Review of the basics of score reading
2. Knowledge of significant musical terms in German, Italian and French.
3. Review of transposition
4. Review of Alto and Tenor Clefs when score reading
5. Phrasal Analysis and Phrasal Analysis Charts as an aid to memorization
6. Knowledge of all beat patterns, including asymmetrical and 'lopsided' patterns
7. Conducting through *ritardandos*, *accelerandos*, and *fermatas*
8. The development of baton and left hand technique
9. The knowledge of the critical difference between time-beating and conducting
10. The development of an articulate and expressive conducting technique and style
11. Basics of rehearsal procedures and technique (see rehearsal attendance requirement)
