## Course Description

This course is an introductory Pickleball class to develop basic skills, techniques and fundamentals. This will include rules, scoring, etiquette, and strategies of play. This course will provide fundamental Pickleball skills through practice, singles and double's play.

1. To acquire fundamental Pickleball skills with proficiency and ability to apply these skills.
2. To gain sufficient knowledge of basic rules, scoring, etiquette and play.
3. To develop knowledge and competency in fundamentals, skills, and game.
4. To develop, appreciate, and commit to adapting movement Pickleball activity for lifetime fitness.

**Skills Assessment (15%):** In-class demonstration of learned skills of the basics elements of Pickleball. Including but not limited to serving, dinks, drives, blocking and basic play and etiquette. A rubric will be given and used for this assessment activity.

**Assignment (10%):** A pre and post self assessment test will be conducted followed by an individual analysis of skill set including fundamentals and techniques and strategy in the game of Pickleball.
