#### CLASS OBJECTIVE:

This intensive writing class will introduce the fundamentals of screenwriting, focusing most directly on the nature and writing of dramatic scenes and the development of interesting and compelling characters. How to express a character - their intentions and objectives - through action within dramatic scenes will be the central objective of this course.

Class goals include helping each student:

- -Acquire a personal, professional writing style in screenplay format
- -Sharpen word choice skills for impact and clarity
- -Understand character, the basis of compelling drama
- -Write from a visual and aural perspective
- -Develop a fundamental understanding of the dramatic scene
- -Understand the *economy* of effective narrative screenwriting and put that understanding to regular use

#### COURSE DESCRIPTION:

Every class session students will be given a writing assignment. Early in the semester you will read your work aloud and everyone will comment on each other's work. This process of creating work, presenting it to your audience (your classmates), learning to deal with and make decisions based on feedback and learning to give effective, helpful and productive feedback to others are the core hallmarks of this class. Later in the semester, pages will be delivered as PDFs for reading before class meetings.

This class is designed to be taken in conjunction with 514a. Though it meets on Tuesdays, and 514a on Fridays, some 513 material will be dealt with on Fridays and some 514a material will be covered on Tuesdays as the course evolves.

513 deals with scenes, scene exercises and short scripts. The 514a component deals with story development, outlining and writing a feature-length screenplay.

#### EXPECTATION OF PROFESSIONALISM:

Assigned material to be handed in is expected to be turned in on time and in the proper format. Assignments will be penalized for grammatical mistakes, spelling errors, format mistakes, and typos. Please proof your assignment prior to submission.

## EVALUATION CRITERIA:

The final grade will be based upon fulfillment of the weekly assignments along with on-going demonstration of the use of the tools discussed in class (30%), the final screenplay as demonstration of understanding the screenwriting craft (40%), two rewritten scenes at mid-term as demonstration of gaining command over scene writing skills (20%), and participation in the weekly give and take of classroom discussions (10%).

Assignments are presented in class unless by prior arrangement; as the first draft script is written, pages will be delivered to everyone in class and instructor via email as PDF attachments. Handed-in assignments will be expected to be properly formatted and free of typos, misspellings, errors in grammar and syntax.

#### WRITING DIVISION ATTENDANCE POLICY:

Students are expected be on time, prepared for each class, and meet professional standards.

CTWR 513 only meets once a week and timely attendance is mandatory and failure to attend all class sessions from beginning to end may affect grades. Students are allowed two absences throughout the semester. On the third absence, students will have their final grade lowered by 10% and an additional 10% for each absence thereafter. Two late arrivals equates to one full absence.

NOTE: Exceptions will be made in the case of religious holidays and DSP accommodations.

Therefore, using AI-generated tools is prohibited in this course, will be identified as plagiarism, and will be reported to the Office of Academic Integrity.
