Course Description

Macroeconomic tries to explain economic environment and events and its dynamic at the national level. We develop variety of theoretical economic models to explain the following topics: long-term and short-term economic growth, unemployment and inflation, interest rate and budget balance. The first part of the course will study long-run economic growth, while the second part of the course will look at models to explain short-term business cycles.

Learning Objectives

- Analyze Economic Models: Develop the ability to critically evaluate and apply advanced
 macroeconomic models. To explain macroeconomic variables using a variety of models and use
 these models to analyze the relationship of different exogenous variables on other variables.
- Deepen knowledge of advanced theoretical concepts such as endogenous growth theory and real business cycle theory.
- Research Methodology: Enhance research skills by conducting empirical analysis using econometric techniques to test macroeconomics theories and assess policy outcomes. To understand how to develop theoretical macroeconomic models.
- Develop the ability to critically read and understand and assess macroeconomic research.

Required Materials

Advanced Macroeconomics, *Romer, D.*, (2019). 5th edition. Papers and other relevant material will be introduced during the semester.

Homework

All problem sets will be posted on the Blackboard. I will announce them in class when they are posted on the Blackboard, however, you are ultimately responsible for periodically checking the system to see whether you have work that is due. Each individual must submit their own entry, however, I encourage you to collaborate and work in groups. Detailed solutions will be posted on the web-site after the homeworks are collected. No late homeworks are accepted, **EVER**!

Research Project

Teams of four members will be required to submit a research assignment (5-10 pages main text + appendices) and deliver a 15-minute presentation about a current topic of debate in macroeconomics. The team members and the research assignment topic should be preapproved by me via email within the first month of class. Presentations must be scheduled with the professor and will take place between during the last month of class. The research assignment will in total account for 20 % of your final grade. Late submissions will not be scored and there will be no make up for the assignments or presentation.

Exams

It is your responsibility to show up on time for the exams. You may not make-up any exams after the scheduled exam dates unless for a valid reason such as illness (written proof required; a job interview is <u>not</u> a valid reason). There will be two mid-term exams and one cumulative final.

Grading
