Course Description

This is a one semester class on entrepreneurship that can run alongside Advanced Game Projects and thesis projects and provides students with information and hands-on mentorship required to start actual companies based on their projects. It is also a good lead-in to the Bridge program. Focus of the class is real world application of business principles in order to maximize the commercial success of their enterprise. The objective of this course is to give students a good understanding of how to build, structure and pitch a startup business with an emphasis on Interactive and Digital Media. Topics will include how to define and communicate a creative vision, protecting your IP, finance (budgeting and P&L), how to organize and structure a company, business models, fund raising (crowdfunding, venture capital, etc), international markets, culture and studio operations.

Students in this entrepreneurial track could be either undergraduate or graduate students in interactive media and their projects could include students from other disciplines such as communications, business, and engineering.

This class content is a combination of instructor lectures, guest speakers, and hands-on workshops. Speakers will come from various disciplines and present real-world facets of starting and operating a company. Guest speakers may include game studio founders, media executives, marketing professionals, CEOs, attorneys and professional specialists.

The first hour of the class is focused on formal lectures and the second hour for hands on mentorship or extended Q&A with guest speakers.

The key output of the course will be a pitch deck for their project either as the structure of a crowdfunding campaign, presentation to potential customers or a pitch to investors.

Students can focus their assignments and discussions around a current game, media project or enterprise they are starting (or will start) but this is not required. Assignments and exercises from the class can be used to support the creation of an operating business entity or used as a template for future business enterprises.

- If you provide minimum-effort prompts, you will get low-quality results. You will need to refine your prompts to get good outcomes. This will take work.
- Proceed with caution when using AI tools and do not assume the information provided is accurate or trustworthy. If it gives you a number or fact, assume it is incorrect unless you either know the correct answer or can verify its accuracy with another source. You will be responsible for any errors or omissions provided by the tool. It works best for topics you understand.
- AI is a tool, but one that you need to acknowledge using. Please include a paragraph at the end of any assignment that uses AI explaining how (and why) you used AI and indicate/specify the prompts you used to obtain the results what prompts you used to get the results. Failure to do so is a violation of academic integrity policies.
- Be thoughtful about when AI is useful. Consider its appropriateness for each assignment or circumstance. The use of AI tools requires attribution. You are expected to clearly attribute any material generated by the tool used.]
