Course Description

The primary objective of this course is to provide an overview of the study of communication and culture. Both cross-cultural (i.e., comparisons of communication across cultures) and intercultural (i.e., communication between members of different cultures) aspects of communication will be examined. Interethnic communication in the United States (e.g., communication between Black/African Americans and Latino/a/x Americans) will also be explored. We will discuss significant theories and relevant research to understand how we can improve the effectiveness of our intercultural communication, manage conflict successfully, and develop (and maintain) relationships with members of other groups in diverse settings.

Student Learning Outcomes

By the end of the semester, you will be able to:

- Identify and Illustrate how culture interacts with social and psychological factors to influence communication;
- Compare and Contrast different culture-based verbal and nonverbal communication behaviors;
- Recognize the impact that cultural issues have on communication effectiveness;
- **Judge** when cultural issues are influencing the development of interpersonal relationships;
- **Identify** ethical issues in communicating with someone from a different culture/ethnic group;
- Illustrate cultural awareness; and
- **Apply** intercultural communication theory and research to practical problems (e.g., organizations, relationships, health, media) and your own life.

This course has no prerequisites, co-requisites, or concurrent enrollment requirements.

General Education Requirement

This course fulfills the general education requirement in **Global Perspectives** (**GE-G**). Course Requirements

1. Course Participation (40 points, 10% of course grade)

This course thrives on each person's energy and engagement! Students are expected to read assigned materials or watch videos before class, come prepared to discuss, and actively engage in activities. Participation also involves attending office hours, scheduling appointments, emailing about real-world applications, and/or using Brightspace resources. Regular attendance is essential for academic success. If you miss a class, catch up by reading the material, getting notes from classmates, and seeking clarification from the instructor, as lecture notes or slides are not provided.

USC policy indicates that "no portion of the grade may be awarded for class attendance, but non-attendance can be the basis for lowering the grade, when clearly stated on the syllabus" (UCOC, March 2019). If students miss more than six classes, their final course grade *may* be lowered (e.g., from B+ to B, B to B-, etc.). 2. Exams (160 points, 40% of course grade)

Two closed-book, closed-note exams will evaluate your grasp of course concepts. Students must bring a laptop or tablet to complete the exam in our classroom, as these exams are in-person. Although the exams are not cumulative, course concepts naturally build on one another throughout the semester. Both lecture material and assigned course readings will be included in the exam; therefore, paying attention to lecture content and thoroughly understanding all assigned readings is essential. The exams consist of true/false and multiple-choice questions.

<u>There are no make-up exams allowed</u>. In the rare event that an *extreme* emergency arises (e.g., you were in the hospital or a death in your family), you must inform your instructor before the scheduled exam time. If your excuse falls within the spectrum of an extreme emergency, we will work toward a solution. Exam I will be held on March 03, 2025, and Exam II on April 30, 2025.

3. Cultural Journey: Self-Discovery to Cross-Cultural Understanding (80 points, 20% of course grade)

Your journey toward intercultural communication competence begins with understanding yourself and extends to meaningful engagement with others' cultural experiences. This three-part assignment sequence guides you from personal cultural reflection through cross-cultural dialogue to comparative understanding. Each step builds upon the previous one, creating a comprehensive exploration of cultural communication. Brightspace provides a more detailed description of each assignment component (see the 'Assignments' module).

- Cultural Autobiography (30 points, due January 31, 2025): Begin your journey by exploring and documenting
 your cultural identity through a 2-page reflection examining how your cultural and ethnic background shapes
 your communication patterns and worldview.
- Intercultural Interview (30 points, due February 14, 2025): Expand your cultural understanding by engaging in dialogue with someone from a different cultural or ethnic background. This 15-minute interview and 2-page summary will help you discover new cultural perspectives and communication patterns.
- Comparative Cultural Reflection (20 points, due February 28, 2025): Synthesize your learning journey in a thoughtful discussion post (minimum 250 words) that explores the intersections between your cultural experiences and those of your interview partner, reflecting on how this understanding enriches your approach to intercultural communication.

4. Cultural Communication Consulting: Analysis & Solutions (100 points, 25% of course grade)

As a cultural communication consultant, you will carefully analyze how cultural differences impact communication within a specific field (e.g., entertainment, sports, technology, healthcare, education). By utilizing cultural variability dimensions, theoretical frameworks, and empirical evidence, you will identify communication challenges, explore their cultural origins, and propose evidence-based solutions. This 6-8 page consulting report will demonstrate your ability to apply course concepts to real-world intercultural communication challenges while developing practical, theoretically supported recommendations for improvement. A detailed description of this assignment can be found in the 'Assignments' module on Brightspace. Due April 18, 2025 (by 5:00 p.m.).

5. Cultural Insights: Ideas Worth Sharing (20 points, 5% of course grade)

For the finale of your intercultural communication journey, develop a thought-provoking question that captures what fascinates you most about cultural communication. This is your "TED Talk moment" - an opportunity to share your unique perspective while demonstrating how course concepts have shaped your understanding of intercultural communication. In this 3-minute video presentation, make your contribution distinctly yours by combining academic insights with personal discovery. Be creative, be thoughtful, and most importantly, be authentic as you explore your chosen question. Think of this as your contribution to the broader conversation about how culture shapes human connection. Your video will be recorded or uploaded through Brightspace's video assignment tool (Bongo). A detailed description of this assignment can be found in the 'Assignments' module on Brightspace. Due May 09, 2025 (during finals week).

Late Submissions

Assignments should be submitted by the dates listed in the syllabus unless communicated otherwise. I understand life can be unpredictable. If you face unforeseen and compelling circumstances preventing timely submission, such as health emergencies or personal crises, please get in touch with me as soon as possible. Assignments submitted after the deadline, without prior discussion, will receive a 5% penalty for each day they are late. I will do my best to accommodate genuine challenges. Always keep me informed.

Assignment Feedback & Grade Inquiries Policy

I am committed to providing timely feedback on your work and will try to grade and post scores within 10-14 days of submission. Please monitor Brightspace for updates. If you notice an error or believe a mistake has been made, inform me within one week (7 days) of the grade posting. To discuss your grade, write a brief explanation of your concerns and email it to me. This process creates a formal record and allows you to present a reasoned case for review. If no inquiries are made within the one-week window, I will assume you agree with the grade, and no further changes will be entertained.
