Course Description

Substantive participation in a production sponsored by the school and supervised by the faculty.

Learning Objectives

- Hone professional acting skills: being one time, attentive, proactive, prepared, flexible and collaborative.
- Apply personal technique to a production situation.
- Creating a role: from impulse through analysis to physical realization and collaboration.
- Embracing an audience: culminating in an audience performance.

Course Notes

This course will take place in person.

An absence is excused for only these reasons: 1. a positive Covid 2. A documented fever. Anything else is NOT excused. In order to receive an excuse you must have documentation of either Covid or a fever. Doctor's notes or evidence to support your claims is imperative. Tardiness is unacceptable and will be treated as one absence.

Description and Assessment of Assignments

Participation: Includes your presence in class - on time and with your proper materialsyour willingness to take risks and respect for others. See "Additional Policies" and "Required Materials" below)

Script Book : You will create a space for you to chart your Active Analysis for yourself. One page of the book will contain the script, the page facing will be blank for the written portion of your analysis. Your analysis will break down into three columns: ACTION/ OBJECTIVE/OBSTACLE. You will find simple actionable language for these three columns that will help you chart your way through your role.

Performance: You will be graded on your performance for your professional and collaborative skills.
