# I. Learning Outcomes

- 1. Develop an appreciation for pedagogical methods in science.
- 2. Develop the ability to properly apply pedagogical methods in science.
- 3. Understand teaching technology and resources specific to teaching science at USC.

# **II. Course Description**

This is a 2-credit TA training course designed specifically for graduate students in USC Dana and David Dornsife College of Letters, Arts and Sciences. One of the main goals of the course is to help students to become thoughtful and inspiring teachers, encouraging not just their immediate success in the classroom, but their long-term development as teachers. In addition to the basic teaching skills, the course will also focus on specific challenges and strategies in teaching. Concurrent registration or prior completion of this course is a condition of being assigned a first Teaching Assistantship.

# III. Grading

This course will be taught Credit/No Credit. Each student will be assigned to give more than one presentation (specific number depends on the students enrolled in the class) that will be critiqued by the rest of the class. The instructor will lead and coordinate the critique discussion. Credit will be based on quality of presentation, class participation and reading assignments.
